

## YOU GET ARRESTED LATE AT NIGHT



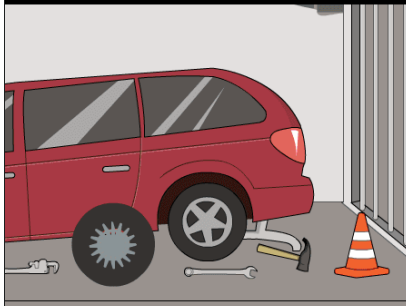
